AVAILABLE PROJECT INFORMATION

The following information is being made available to Bidders for informational purposes only and is not a part of the Addendum.

CONTRACTOR QUESTIONS

Q: Please Clarify scoreboard requirements?

A: The base bid includes two (2) new scoreboards and alternate bid includes one (1) scoreboard. The Contractor is required to furnish the scoreboards and install per the manufacturer requirements. Contractor shall provide all material for the complete install.

Q: Drawing TS100 note #2 shows a 2" conduit going from data cabinet to press boxes. It is assumed this is for future communications as nothing is noted here to put into conduit. However, Drawing T-501 detail #1, note #1 indicates to provide cabling and grounding to school AND pressboxes. This is confusing since nothing is called out on TS100.

Please clarify if 2" conduits to pressboxes are for future or to have fiber in them; and if grounding conduit and if 750 kcmil grounding wire and conduit is required to pressboxes and school or if empty conduit for future should be included.

A: The intent is that the conduits on sheet TS100 are to have fiber and pull-string installed from the Elementary school to the new Concessions building and also to the pressboxes. Grounding is to be connected to any building grounding that will be new or is existing. Install cabling per sheet T-501 and specifications.
