Repairs and improvements to Cadillac High School Football Stadium Grandstand.

Concrete repairs, waterproofing and painting.

Slab on grade repairs, including replacement, grinding of elevated slab edges, Grandstand floor slab repair, various vertical and overhead concrete repairs, expansion joint repair, joint sealant replacement, routing and sealing of cracks, traffic topping repair and recoat application, minor electrical repairs, painting of pathways, painting of exterior concrete façade faces.

Painting of interior vertical and overhead concrete surfaces is included as an Alternate.


