Clarification No. 1. Demolition work includes the removal of existing stage floor assembly, framing, sleepers, subflooring, and preparation to receive new flooring assembly. Refer to A1.1B Demolition Note 10 and refer to Section 09 64 00, 3.3 Installation.

B. Bid Category No. 2 – Electrical.

Add the following Clarifications:

Clarification No. 1. The \$2,500 Allowance specified in Section 27 41 16, Part 2.1 E, shall be included as part of the \$10,000 Allowance specified in Section 01 23 00 Allowances. The total cost of all Allowances to be included in the contractors bid shall be \$10,000.
