This Addendum consists of Pages ADD 4-1 through ADD 4-2, and Specification Section 00 31 00 Bid Form.

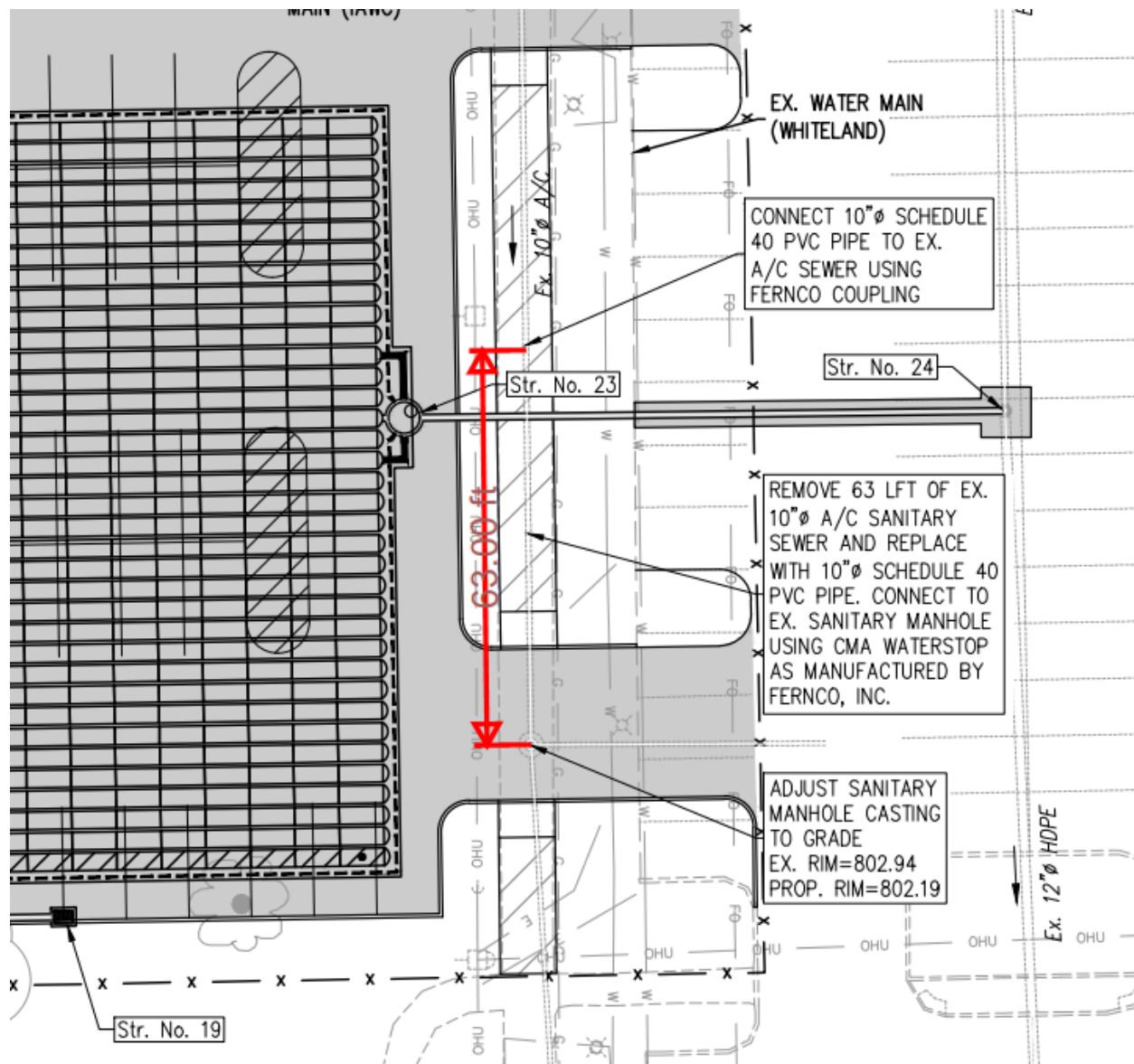
A. SPECIFICATION SECTION 00 31 00 – BID FORM

1. DELETE entirety of this specification section and replace with 00 31 00 – BID FORM section included as part of this addendum.

B. Bid Category No. 1 – General Trades

Add the following project specific clarifications.

1. The total storage volume of the ADS SC-310 chamber system in parking area ‘A’ is 28,199 cu. ft. as measured from the bottom of 6” stone base (elev. = 797.91) to the top of the 9” stone above the chambers (elev. = 800.49). The total storage volume of the ADS SC-740 system in parking area ‘B’ is 49,762 cu. ft. as measured from the bottom of the 9” stone base (elev. = 797.20) to the top of the 6” stone above the chambers (elev. = 800.95).
2. 63 LFT of sanitary sewer replacement starts at the existing manhole and extends upstream (north) beyond where the new storm sewer connecting Str. #23 and #24 crosses the sanitary (see below).
