

 - A. Clarification: Note #4 is not applicable to scope on this sheet..

 - A. Sheet C-301 will be issued in the Construction Set, however, there are three details included in this Addendum that are included on that new Sheet.
 - B. See Detail 1/C-301, included with this Addendum, for the Detail of the Concrete Sidewalk.
 - C. See Detail 2/C-301, included with this addendum, for the rolled edge along the soft-play playgrounds that is to be coordinated with the Soft Surface Contractor. Note that the alignment and termination along asphalt edges is similar to Detail 3/C-301.
 - D. See Detail 3/C-301. Included with this addendum, for the trench drain set in concrete and site transition detail. Note: Contractor is responsible for determining the final inverts for the trench drain based on filed conditions and select the specific trench drain for sloe that is required.




CONCRETE SLAB SIDEWALK DETAIL
