**A. SPECIFICATION SECTION 01 12 00 MULTIPLE CONTRACT SUMMARY**

**A. BID CATEGORY NO. 01 – SITEWORK**

Add the following clarification:

Clarification No. 01: **Bid Category No. 01 – Sitework** will provide all grading and compacting within a tenth of a foot (plus or minus) of the final elevation for all asphalt and concrete paved areas. **Bid Category No. 01 – Sitework** shall also provide additional aggregate as needed by the other trades to perform their final grading or minor adjustments.

Clarification No. 02: Each Contractor shall provide dumpster(s) as required to perform their own portion of work. Delivery and placement of all dumpsters shall be coordinated with the Skillman Site Manager.

**B. BID CATEGORY NO. 02 – ASPHALT PAVING**

Add the following clarification:

Clarification No. 02: Each Contractor shall provide dumpster(s) as required to perform their own portion of work. Delivery and placement of all dumpsters shall be coordinated with the Skillman Site Manager.

**C. BID CATEGORY NO. 03 – CONCRETE**

Add the following clarification:

Clarification No. 02: Each Contractor shall provide dumpster(s) as required to perform their own portion of work. Delivery and placement of all dumpsters shall be coordinated with the Skillman Site Manager.

Clarification No. 03: All railings and signage shown on the Civil Plans shall be provided and installed by **Bid Category #03 – Concrete**.

**D. BID CATEGORY NO. 04 – ELECTRICAL**

Add the following clarification:

Clarification No. 02: Each Contractor shall provide dumpster(s) as required to perform their own portion of work. Delivery and placement of all dumpsters shall be coordinated with the Skillman Site Manager.

Clarification No. 04: **Bid Category #04 – Electrical** is responsible for layout and installation of the light pole bases as indicated on the Electrical Site Plan ES 001 and detail #01 on ES 001. This includes coordination with the Sitework and Concrete Contractors for proper layout and sequencing of installation.
